**A RESOLUTION OF THE CAMPBELL COUNTY FISCAL COURT
ALLOCATING SENIOR CITIZENS TAX FUNDS FOR FY 2017**

WHEREAS, the Senior Citizens tax fund allocations for FY 2017 will total **\$571,150**;
and

WHEREAS, the agencies providing services to the 60+ year old population have submitted applications for FY 2017 regarding the services each agency will provide to the residents of Campbell County; and

WHEREAS, the Fiscal Court has reviewed the requests for funding from such agencies,

NOW, THEREFORE, BE IT RESOLVED that the Campbell County Senior Citizens incoming Payroll Tax funds for FY 2017 be allocated to the agencies serving older adults in the amount of **\$306,000** in accordance with the attached allocation list,

NOW, THEREFORE, BE IT FURTHER RESOLVED that Campbell County Fiscal Court allocate an additional **\$265,150** as follows:


