Mr. Verst called the meeting to order at 7:00 PM. Mr. Verst asked for a roll call. Following roll call, a quorum was found to be present. Mr. Verst asked if everyone had read the November 16, 2010 meeting minutes and if there were any questions or corrections. Mr. Mason noted that on page eleven on the second sentence in the second paragraph the word "conversation" should be replaced with the word "questions". Mr. Verst asked if there were any other corrections. There being none, Mr. Verst called for a motion. Mr. Schaber made a motion to approve the minutes as corrected. Ms. Reitman seconded the motion. Mr. Verst called for any other nominations. There were none. Mr. Verst called for a motion. Ms. Reitman made a motion to elect Mr. Roger Mason as TPO, Mr. Dave Schaber as Vice Chairman and Mr. Justin Verst, Chairman. Mr. Mason seconded the motion. A roll call vote found Mr. Bachmann, Mr. Johnson, Mr. Mason, Ms. Schweitzer, Ms. Reitman, and Mr. Schaber in favor. Mr. Verst abstained. Motion passed.

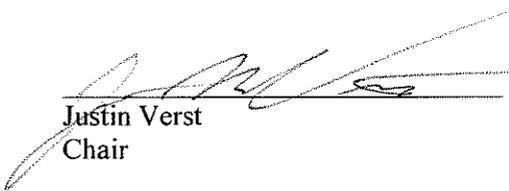
